COMMUNITY OUTREACH OCCURRED AT 167 UNIQUE EVENTS AND RESULTED IN 12,046 RESIDENTS RECEIVING FREE VACCINES, COVID-19 TEST KITS, EDUCATIONAL INFORMATION, AND/OR RECEIVING OTHER NO-COST RESOURCES.
